

Sneak Preview of Omaha, Nebraska - 2013 National Convention



The Iota State/NE Kappas are anticipating welcoming you to the "Good Life" in Nebraska at the 2013 National Convention. Omaha, one of the top 10 best

cities to live in, is a visitors' paradise that features the world class Henry Doorley Zoo, Joslyn Art Museum, and Mormon Winter Quarters. The newly renovated Doubletree by Hilton Hotel Omaha Downtown turns travel into a human experience, located in the heart of downtown Omaha. Complimentary airport shuttle service is available from/to Eppley Airport, as well as complimentary local shuttle service, too.

On Wednesday, June 26, the **Pre-Tour** will be a day of exploring! The tour begins in West Omaha with a visit to the world-famous Father Flanagan's Boys Town, an inspirational stop where we learn how Father Flanagan offered troubled boys a chance to get off the street by providing them shelter, food, clothing, work trade skills, faith, and love. The next stop, Soaring Wings Vineyard, is perfect for lunch and wine tasting. Ex-pilot Jim and wife Sharon started their operation in March of 2002 and have been welcoming guests to learn about Nebraska wines at their tasting room, overlooking the Platte River Valley. Our next visit is the Weiss Sculpture Gardens that feature delicate copper creations, bronze sculptures, and beautiful hand-forged ironworks. One last stop at the Holy Family Shrine features a beautiful structure welcoming people of all faiths.

On Thursday, June 27, Kappas and guests have the chance to enjoy a **Nebraska Cowboy Roundup & Chuckwagon Dinner Tour** for a memory-filled evening of Wild West cooking and campfire fun at the Bellevue Berry & Pumpkin Ranch. Saddle up for some down home country vittles and an evening of fun entertainment for the entire family. So, dust off your boots, polish up your spurs, and get ready for a wild time in the ol' West, 'cause this is sure to be an evening you won't forget.

On Sunday, June 30, the **Post Tour** will depart for Iowa to the Salisbury House and Gardens, Listed on the National Registry of Historic Places in 1977, built in 1928 for \$3 million, this wonder was modeled after the 42-room Kings House in Salisbury, England. Monday will take us to the Amana Colonies where we will learn about the 18th Century German settlers who founded the seven villages of the Amana Colonies and developed a communal style of living that has become America's oldest communal society. Next is Pella, Iowa - a charming and well kept Dutch community where a local restaurant will host a Dutch dinner and provide entertainment. On Tuesday, we will tour the Pella Museum, which houses a 22 building complex that honors Pella's Dutch founders and early Iowa settlers and includes the tallest working windmill in the United States. To end our time in Pella, we will see the Klokkenspel performance - a 147 bell carillon clock. Winterset, Iowa, our last stop, was made famous by the novel Bridges of Madison County.

Notification of Proposed Bylaw Changes

At the 2012 National Convention in Tennessee, under New Business, Parliamentarian Anne Baker announced that the Executive Committee had approved to propose Bylaw changes to reduce the National Executive Committee by one (1) member and duties to be reassigned, as appropriate, with vote on changes to take place at the 2013 National Convention in Nebraska.

The Executive Committee has forwarded the following Bylaw changes to the Bylaws Committee to be presented:

- 1) Bylaws page 7: Article VI – OFFICERS, Section 1-Elected Officers, A. The officers of the National Chapter shall be: **delete** #5. "Third Vice President" (**renumber** #6. #7. to #5. #6).
- 2) Bylaws page 10: Article VI – OFFICERS, Section 4-Duties of Officers, **delete** D. "Second Vice President" and #1. #2. #3., **reletter** E. to D. **changing** "Third" to **Second**, **reletter** F. to E. Recording Secretary, **adding** #3. **Serve as chair of the History Committee.** and #4. **Assist the President in preparing the President's annual report for The Legend of the Violets' file.** (**reletter** G. to F.)
- 3) Bylaws page 12: Article VII – EXECUTIVE COMMITTEE, Section 4-Quorum, **change** "five (5)" to **four (4)**.
- 4) Bylaws page 15: Article X – COMMITTEES, Section 4-Duties, G. History, **delete** #2. "Compile the National President's Book to reflect the term of office." (**renumber** #3. to #2.)

Mu State/MS Holds First Ever Strategic Planning Retreat



Mu State (Mississippi) holds a first this year. Mu State President Mitzy Johnson-Mills appointed an ad-hoc committee, the "Mu State Strategic Planning Task Force", to establish strategic planning goals and objectives to move Mu State Kappa towards our national organization's mission. In June, a *Kappa Assessment Survey* was mailed to Mu State Kappa members who had not renewed their membership over a period of time (from one to five years). This survey served as a component of the Mu State Kappa's overall plan regarding retention of members. On July 21, 2012, the Task Force consisting of Mu State Executive Officers, Mu State Standing Committee Chairs, Past National President, and representation from Past State Presidents gathered in Columbus, MS to review the findings of the survey along with environmental scanning of a five year Mu State Membership Report and review of the National Kappa Membership Recruitment PowerPoint presentation. The Task Force performed a Strengths, Weaknesses, Opportunities, and Challenges exercise and then broke out into teams to develop strategic long-range planning goals. During the Mu State Fall Workshop in August, the Task Force created objectives to complement the strategic long-range planning goals.

The following Oliver Wendell Holmes quote summarized the strategic task at hand: "Greatness is not in where we stand, but in what direction we are moving. We must sail sometimes with the wind and sometimes against it-but sail we must, and not drift, nor lie at anchor."

Lorene is very active in the Nebraska State Education Association -Retired, as well as Kappa Kappa Iota. Each year, Lorene creates a unique and imaginative quilt that is raffled off. This year's quilt raised \$743 for association projects, which brings her total to over \$10,000 contributed. She has successfully combined her artistic talent with a wonderful philanthropic project. She was featured in the NSEA-Retired Newsletter with this year's raffle winner, Aaron Stearns, the 10-year old grandson of a member.

Ann Danner created an award winning outdoor education program that began with a small pilot grant 35 years ago. Ann has been the driving force in the growth of this wonderful environmental experience which includes a two day overnight camp. Study units cover: the forest, soils and prairies, fresh water, environmental activism, and a trust course that builds leadership. The program is now part of the curriculum of the district, and all sixth grade students benefit from this unique learning experience. Her efforts have earned her the Nebraska Environmental Educator Award and Outstanding Educator for the Papillion LaVista School District. Ann continues to be a driving force in the continual program improvement.

Both of these Kappas continue to lead by example and are making their communities a better place to live. They are the working and helping hands of Kappa.
