A Little Bit of This and A Little Bit of That

Dues Increase ~ Changes to Standing Rules

The National Executive Committee, following a 2-year study with the Business Committee and Staff, will be presenting a proposed \$10 dues increase to the delegates at the 2014 National Convention in Atlanta/GA this June, to become effective with the 2015-2016 fiscal year. Notice of this proposed increase was presented to the 2013-2014 State Presidents at their joint meeting with the National Executive Committee this past October in Tulsa/OK.

The last dues increase was proposed in 2008. A 5-year plan was put into place at that time, which would have meant presenting the next dues increase in 2013 to take effect in 2014-2015. Due to the generosity of our Kappa members, the careful watch over our investment plan in reserving available funds, cutting of expenses where possible, and the wise stewardship of those funds by the Business Committee/Executive Committee/and Staff, the time for the need for presenting an increase was delayed until 2014 to take effect for the 2015-2016 fiscal year.

The following Standing Rules (page 8) will be presented for approval to implement the proposed dues increase:

FEES AND DUES 1. New Member/Member - Dues for a new member/member shall be forty dollars (\$40) and twenty dollars (\$20) for a campus member. State dues shall be specified by the state chapter, and local dues shall be specified by the local chapter.

FEES AND DUES 2. A. National fees for honorary and Associate Life Memberships shall be four hundred dollars (\$400).

The National Executive Committee, Business Committee, and Staff ask for your support in approving the proposed dues increase.

You do not need to be present to win. The proceeds from this project will go to our Capital Improvements Fund for the upkeep of our National Headquarters and property.

Books and Bears

Make sure to send or bring your books and bears to Atlanta. Gifts will be presented to the Pike and Fayette County Sheriff Departments to provide "comfort" bears to help ease the pain and fear of traumatized children. Books will go to The Children's Village at Christian City, an organization that provides children a safe environment in loving, family-centered residential settings.

National Scholarships/Grants

JUNE 1, 2014 is the deadline to submit National Scholarship Applications for consideration. Applications are available from the website, State Presidents, and/or National Headquarters.

The total number of awards each year is based on funds available and the number of qualified applicants. Scholarships and grants are awarded for professional or personal enrichment. Scholarships are available for Non-Members, Active Members, and Campus Members.
