

It was an honor to report the 2018-2019 Philanthropic numbers at the National Convention in Cleveland, Ohio. Each member has the opportunity to give back to the community in monetary donations or their time and talents in the name of Kappa Kappa lota. Members also help support the Kappa House Headquarters. I am always amazed at the final amount of volunteer hours and monetary donations made by members of Kappa Kappa lota each year.

The numbers shown do not reflect the generosity of members who donated at the National Kappa Kappa lota Convention for Scholarships, General Fund (Any Area of Need) and those earmarked for Kappa Headquarters emergency repairs (needed due to the May storms). Those donations are shown above. Members of Kappa Kappa lota have big hearts and deep pockets!

The following amounts were reported at the 2019 National Convention in Cleveland, Ohio:

- ♦ \$2,547.50 money donated to the Kempe Children's Foundation
- \$79,766.45 money donated in the name of Kappa Kappa lota to local centers for battered adults and abused children, as well as to any other charities and non-profits
- \$94,928.05 monetary value of clothing, food, and other items donated in the name of Kappa Kappa lota to local centers for battered adults and abused children, as well as to any other charity or non-profit
- \$1,026,438.90 money donated other than in the name of Kappa Kappa lota
- \$238,073.26 monetary value of clothing, food, and items donated other than in the name of Kappa Kappa lota
- 55,447.5 hours volunteered in the name of Kappa Kappa lota
- 121,996.2 hours volunteered other than in the name of Kappa Kappa lota
- \$22,018.50 money given to Kappa Kappa lota Scholarships
- \$3,679.50 money given for the upkeep and improvement of Kappa Kappa lota National Headquarters

There were 80 total number of projects reported, 205 members involved in projects, 8,563.5 hours devoted to the projects. I believe these numbers are under reported. I hope that the information provided for 2019-2020 clearly reflects the involvement of the number of members involved in projects reported.

The grand total of hours volunteered for 2018-2019 is 177,443.7 hours and total monies or monetary value donated is \$1,267,552.16.

All Kappa Kappa lota members should give themselves a pat on the back for their generosity of time, money, and talent given back to their communities as well as their support of Kappa's Philanthropic mission.

From National President Chris Hockert...



Kappa Headquarters Damage Report

Tulsa was all shook up from storm damage in May. Severe thunderstorms, heavy rain storms, and tornados caused catastrophic damage to Kappa Headquarters. In the office of Executive Director Marilyn Bridges there is damage to the ceiling, walls, printer, computer back up system, and furniture. There was four feet of water in the basement causing electrical failure to the sump pumps, loss of heat, air conditioning, and damage to the dehumidifier and hot water tank. The living room ceiling suffered damage

due to extraordinary heavy rain fall, damaging furniture and carpet.

If this wasn't bad enough, it was determined that the City of Tulsa decided to shut down the electrical grid. In addition, the City of Tulsa water treatment facility backed up sewer water into the basement as part of the four feet of water. It cost over \$3,000 just to pump out the basement. Our insurance company has not reimbursed us for any of the expenses we have incurred to date. They are attempting to compensate us for damages in the basement and deny responsibility for the total damages incurred.

Headquarters also received wind damage to the roof, gutters, and drains. It cost over \$6000 to repair the roof. This damage combined with the sewer water in the basement has allowed mold to grow and flourish! An air quality analysis was conducted at Headquarters and it was determined that there were five types of mold in the building. The report stated that the building was not fit for habitation. This report cost over \$1800. We have had to repair the electrical unit, purchase new dehumidifiers, sump pumps,



hot water tank, gas furnace, and much more. Headquarters' damage, mold removal and repairs have been our number one priority since May.



In brief, because the air quality test performed showed very high levels of various types of mold forcing us to vacate the premises, Executive Director Marilyn Bridges has been working from home and using her cell phone and internet service to conduct Kappa business. There have been several Zoom meetings with decisions made to include hiring an attorney to represent Kappa to deal with the insurance company, early withdrawal of funds from a General Fund CD to pay for the attorney retainer fee, receiving three estimates for mold removal (cost estimate just to remove the mold is over \$13,000 and this does not include costs to repair the damage to headquarters from mold removal), and repair. Our insurance company arranged for a second site visit by a building forensics engineer to review damage due to the result of mold. We will not know the result of this site visit and report recommendation until mid-August. It is estimated that once we receive approval from the insurance company to proceed with mold removal and repairs it will take 7-10 days for mold removal. Then another air quality analysis has to be done (\$1800.) to determine if all of the mold is gone. If

the mold still exists there is another 7-10 days to continue locating and removing the mold before any final repair work can be performed. The contractors estimate that it will take at least three to four weeks to do repair work. An estimate to cover these costs cannot be determined until after the mold is removed. This could easily be another \$8,000. to \$10,000.

Based upon these factors, the National Executive Committee made the decision to hold the Fall Executive Committee and State Presidents' Meeting at the Crowne Plaza Hotel because we cannot guarantee that the repairs will be completed in time to utilize Kappa Headquarters. Rest assured that the National Executive Committee and Executive Director Marilyn Bridges are working hard to effectively deal with the insurance company through our attorney so that we can be back to "Normal Business" in the near future.
